
**ORDER**

At a hearing held in open court on January 15, 2010 on Plaintiff's Motion for Injunction under Tribal Court Civil Rule 9, the Parties agreed upon the disposition of the Plaintiff's Motion by agreeing as follows:

- 1) Defendants agree to immediately close the All Inn Lounge bar and place a sign in the building that the bar is closed "indefinitely";
- 2) All alcohol for sale shall be removed from the premises under the supervision of the Tribe's Compliance Department and the Tribe's Police;
- 3) The Tribe's Compliance Department and Tribal Police shall be granted access to the bar portions of the premises to enforce this agreement; and
- 4) If there is a violation of the order, the Plaintiff will re-file its Motion for an Injunction; and
- 5) Plaintiff agrees to remove Tony Laughing Sr.'s name from the Complaint.

IT IS HEREBY ORDERED that the Court approves the agreement of counsel and enters this Order recognizing said agreement.
