The Owner will not reimburse any bidder for expenses to attend this meeting.

Checks and money orders are to be made out to the "Saint Regis Mohawk Tribe".

Bid security is a mandatory requirement of this call.

Preference in the award of the Contract shall be given to Indian and Alaskan Native organizations and economic enterprises. Any contractor claiming Indian Preference shall give evidence, as required by the Owner, to support this at least one week prior to bid opening. All preferences shall be announced prior to the bid opening.
