Separate sealed BIDS will be received by the Grants & Contracts Office, Saint Regis Mohawk Tribe, 2nd Floor Community Building, 412 State Route 37, Akwesasne, New York 13655 until 3:30 p.m., (local time), March 31, 2016, for the replacement of waterline from the Saint Regis Mohawk Tribal Police Department to Roosevelt Road at the Reservation Line as the Base Bid, and ADD ON No. 1 from the Reservation Line 3,700' west on Roosevelt Road; and then Traffic Circle Road consisting of:

BASE BID: Includes the Installation of 14,300 Lineal Feet of 8" water main and appurtenances.

ADD ON NO. 1: Includes the installation of an additional 6,700 Lineal Feet of water main and appurtenances.
