VEHICLES ARE SOLD AS IS


Saint Regis Mohawk Tribe will not be responsible for defects

1. Bidder must be 18 years of age or older to submit a bid on the vehicles or motor that is being auctioned.
2. The vehicles or motor to be auctioned may be inspected Monday through Friday until the day of the auction on March 25, 2016 at locations specified on Sealed Bid Auction Sheet. Please contact Procurement for Inside inspections.
3. To be accepted, the bidder is to include the amount of their bid, bidder's full name, address and telephone number(s) and cell number.
4. All bids are to be submitted to the Procurement Office, Saint Regis Mohawk Tribe, 412 State Route 37, Akwesasne, New York, telephone (518) 358-2272, extension 2186.
5. Bids will accepted through March 25, 2016 at 3:30 p.m., bids received after this date and time will not be accepted. Bids must be hand delivered in sealed bid envelope package to procurement office by above stated date and time.
6. Vehicles or motor are sold as is, where is, with no guarantees or representation made as to the condition or model year. NO REFUNDS WILL BE MADE. The Tribe holds no responsibilities for refunds of this vehicles.
7. Do not bid if you do not intend to honor your bid.
8. Should you be the successful bidder, you will be notified and you must pay for the vehicles or motor by making your payment to the Accounting office of the Saint Regis Mohawk Tribe. The highest bidder, once notified, has until 30 days after the auction to pay for and remove the vehicles. If a bidder is unable to remove the vehicles they will forfeit their claim to the vehicles or motor. All bids will remain confidential until after the opening of the bids, at which time the highest bidder will be contacted by phone. The Saint Regis Mohawk Tribe will accept cash, money order or cashier check (made out to the Saint Regis Mohawk Tribe), no personal checks will be accepted and no third party or payroll checks are accepted.
9. In the event of two identical bids are received, the bid received first will be accepted.
10. After the vehicles has been paid the Saint Mohawk Tribe will issue a Bill of Sale.
11. The Saint Regis Mohawk Tribe assumes no responsibility for injury or damage involved in the acts of the purchaser or their agents.
